SCRIP TUITION CREDIT PROGRAM AGREEMENT 2007-2008

The purpose of the Scrip Tuition Credit Program is to allow St. Anthony School families to generate reductions in their family's tuition costs by purchasing Scrip certificates. Scrip certificates are gift certificates provided to St. Anthony's Scrip at a discount by participating retailers. These certificates are sold to and redeemed by St. Anthony School families at face value by the retailer. The difference between their cost and their redemption value (Scrip contribution) is used by St. Anthony School. In an effort to reward school families for their participation in the St. Anthony Scrip, the Scrip Tuition Credit Program allows participating families to earn a credit toward their 2008-2009 tuition.

SCRIP TUITION CREDIT GUIDELINES

1. As stated above, Scrip generates funds by obtaining gift certificates from participating merchants at a discount and selling them at face value to program participants. The difference between these amounts is the "Scrip contribution".
2. School families will receive 25% of their total Scrip contribution generated by their family's Scrip purchases throughout St. Anthony Scrip's fiscal year, which is from July 1st, 2007 through June 30th, 2008.. A minimum credit of \$30 must be earned in order to receive the credit. Then, the remaining monies will be given to St. Anthony School. The school family's credit will be distributed based on the signed contract attached to this form. If this contract is not returned by the end of the fiscal year, that family's credit will be donated to the school.
3. Tuition credits earned during the 2007-2008 school year will reduce the participating family's tuition costs for the 2008-2009 school year. In the event that a participating family is leaving at the end of the school year or their final child is graduating from St Anthony's, the monies will be donated back to St. Anthony School.
4. Participating families may accumulate tuition credits up to \$599. Your credit will be deducted from your family's first tuition payment of the school year. If your tuition credit is more than your family's first tuition payment, the remainder of the credit will be deducted from the future payments.
5. The Scrip contribution generated by each participating family will be accounted for on a daily basis. Participating families will receive a quarterly statement of their family's contribution for that quarter.
6. As the Scrip Tuition Credit Program evolves, additional guidelines, regulations, etc., may be identified and implemented at any time.
7. St. Anthony Scrip is not responsible for any expired, lost, or stolen certificates.
8. St. Anthony reserves the right of administrative interpretation regarding this plan.
